DOSA: PLAIN RICE CREPES. INGREDIENTS: RICE BATTER MIXED WITH CHILLIES, REDPEPPER & SPICY INDIAN SPICES

The contest consists of **TWO** qualifying rounds. In each round, two contestants who finish **THREE** spicy dosas in the fastest time wins that round and moves on to the **Final Round**.

The **final round** will have **FOUR CONTESTANTS**.

In the **FINAL** round, the contestant who eats the most **dosas** in **TWO MINUTES** wins the entire contest! (Completely finished Dosas will be counted)

The first **TWENTY FIVE** forms received will be the final contestants for the Competition unless of any changes the next received form will be considered.

Once the forms are received the final contestants will be informed and names will be posted in the restaurant prior to the Contest.

There will only be a **SINGLE WINNER NO RUNNERS UP**.

In case of a disqualification or a **NO SHOW** of the contestant on the day of the event any available contestant at that event will be considered to replace.

(Has to comply with the Rules and regulations and sign documents accordingly of the event)

RULES AND REGULATIONS

- Contest is open to all Canadian residents 18 years or older. (Need to show proof of residency, drivers license or a Canadian valid Id)
- Employees, owners, and members of their immediate families are not eligible to participate
- The last date for the submission of the participating form with the required documents is Saturday 17 July 2010 before 10.00pm
- The participant has to be present at the location no later than 3:30 pm on the day of the event for final instructions
- The contestant will be assigned a seat number which will be picked by the contestant randomly at the event where he/she will be seated, no changes once seat assigned
- The contestant will have the Spicy Dosas wrapped in Silver foil which he/she has to open it just before the Judge signals the GO
- The contestant will not take any help other than himself/herself in eating the Dosas.
- The contestant is not supposed to touch the Dosas in any circumstance before the Official gives the signal
- Every contestant will be given bottles of water
- The contestants **HAVE TO EAT** standing in their designated area.
- Once the go signal is given the contestant can have the Dosas however he/she likes by breaking it into pieces or just shoving it in
- Only completed dosas will be counted and any pieces leftover would be left out.
- The contestant will not drop pieces of Dosas on the ground.
- The contestant will stop eating Dosas the moment the Judge signals the stop of the contest i.e. the end of **TWO MINUTES** (final round)
- Upon stop signal by the official, everyone stops eating, any piece or pieces of Dosa in the contestants hand will have to go back on the plate
- Any Dosa in the mouth of the contestant will be considered as eaten, the contestant has to eat that piece or pieces without dropping it, in **TEN** seconds.
- Anyone who suffers from throwing up during the competition is disqualified immediately.
- In case of the winner throwing up the next most eaten Dosa contestant will be awarded the winner.
- Failure to follow any of the above will result in disqualifying from the contest
- Once the contest is over, competitors can rid themselves of the food they've just eaten however they like **away** from the location of the event
- **NO replays, Judges decision is final**

PRIZE AWARDS:

Prizes will be awarded as follows for the winner:

- **Contestant (winner) who eats the most Spicy Dosas in the final round within the allotted time will receive the Grand Prize of \$100 Gift Certificate**
- **\$100 Cheque from Udupi Palace Restaurant.**
- **The winner will also receive a Trophy.**
- **All other prizes, if any, will be announced**

GROUND FOR DISQUALIFICATION

Any health risks that could jeopardize the contestant’s health or wellbeing

- Under the influence of any substance
- Appearance is deemed inappropriate or unattractive
- Failure to report by 3:30 pm or failure to stay in designated waiting area after reporting
- Starting prior to the start signal.
- Continuing to eat after the ending signal.
- Holding the food in the mouth for longer than TEN seconds after the stop signal.

Note: The organizers of this event (**Udupi Palace Spicy Dosa Eating Contest**) reserves the right to disqualify any contestant for any reason without explanation and participating fees will not be refunded.
